Dear Parents:

The registration packet for the 2010-11 Religious Education school year is attached. Please read it carefully, complete **both sides** of the registration form; one form please for each child in your family. **We encourage you to send the registration to us through the mail or drop it off at the SRE office.** You need to send the completed forms, along with your check, a self-addressed, stamped business-size envelope, and a copy of your child's baptismal certificate for new students, as well as sacramental preparation students (if you have not given us one already.) **No new registrations will be accepted without a copy of the child's baptismal certificate!** Families must be registered in the parish in order to have their child enrolled in our program, otherwise there is an "out-of-parish" fee. Registration is on a first-come, first-served basis. **Classes fill up early, so please send in your registration quickly in order to get the day and time of your choice.** There is a \$15 discount for all families who complete their registration by June 24, 2010. **Classes will begin the week of September 20, 2010.**

"Early Bird" Registration will start on May 1. We will appreciate receiving all registration forms **no later than June 24.** We will close the Religious Education office on that day until Monday, August 16 for summer vacation.

Your **check needs to be attached** to the registration form(s). This year, in addition to paying by check, you can select to pay by using a credit card and completing the attached credit card form. Please see the attached fee schedule. If you so indicate, your check can be put on hold until August 16 and then deposited. Early registration by June 24 is cost effective; it allows us to order student materials in bulk, save on shipping costs, and you benefit by taking advantage of the "Early Bird" registration. **Please note: Registration forms will not be processed if package is not complete.**

Fees must be paid at time of registration. If you are unable to pay the total due at time of registration and will need to have a payment plan, please enclose an initial payment of \$25 and send us a letter advising us of the difficulty. There will be no refund after 1st week of classes. Enrollment fees include the cost of books and other materials.

When you complete the registration form (**both sides**), please circle your preferences with regard to day and time of class (bottom left side of the form). We will do our best to accommodate you. We will send you a confirmation slip in the self-addressed, stamped envelope you provided.

If a child has any special needs, i.e., wheelchair access, a learning disability, or anything which might need special attention, please make sure to complete the appropriate line on the registration form or if you need more space add a line or two to the back of the form before signing it.

Our policy is and has always been to place children on a first-come, first-serve basis. Because we have an all-volunteer teacher program, it is important for us to know as soon as possible, but in any case **before June 24**, how many volunteer teachers, co-teachers, and aides we will need. If you can volunteer please let me know and I will advise you of the diocese's requirements.

Also attached is a Volunteer form. Please look over the different ministries we have in our parish, in particular the Religious Education Program, and sign up right away. The Lord will richly bless you for your commitment to his people.

Your signature on the registration form indicates that you have read and agree to follow the School of Religion policy statements.

If you are **NEW** to our parish, please do not forget to stop by the Church office to register your family so as not to pay an "out-of-parish fee."

We highly encourage you to bring your child (or children) to Religious Education classes throughout the years **from preschool through eighth grade.** Each year builds upon the previous year and helps the child learn more about their Catholic faith in a systematic approach without any wide gaps of knowledge. It helps the child to see that their faith is the most important thing in their life and that their whole lifetime is a continual spiritual journey with

Jesus Christ. What better way is there than to combine the best of both worlds, that of loving, living, and learning about their faith with you as their parents/guardians, and in partnership with the Church in their Religious Education classes! We are very fortunate to have such faith-filled and dedicated parents and catechists! Please encourage family and friends to register their children as well.

It cannot be stressed enough that the most important thing we can do as parents is to attend Mass every Sunday or the Vigil on Saturday with our children. The Mass is the highest form of praise and worship, and it is how we come together as a family of faith to be fed with the Word of God and the Body and Blood of Jesus Christ. What can be better than that in our lives! Also, please remember that liturgy leads to faith formation and faith formation leads to liturgy. The two go hand-in-hand, supporting and strengthening one another.

The last week of class will be that of May 24 and 25. We hope and pray that you and your children had a wonderful year and are much closer to our Lord. Thank you for your cooperation during the year and your participation in our program. Please remember to continue to attend mass during the summer months as well. We cannot take a vacation from God! God bless you and have a wonderful summer.

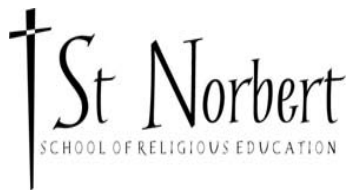

SAFETY REQUIREMENTS FOR PARENTS AND STUDENTS

Please read carefully before signing. Thank you.

THE FOLLOWING SAFETY POLICIES MUST BE ADHERED TO BY ALL PARENTS AND STUDENTS IN THE RELIGIOUS EDUCATION PROGRAM AT ST. NORBERT. FAILURE TO ADHERE TO THESE REQUIREMENTS MAY RESULT IN THE DISMISSAL OF THE CHILD FROM THE PROGRAM.

ARRIVAL AND DISMISSAL PROCEDURES:

ALL children in grades 1 – 6 must be walked to the classroom before class and met at the classroom or designated area in parking lot after class by the parent or parent-designated adult. In case of inclement weather, we would appreciate all parents coming to the classrooms to pick up their child. A parent-designated adult must be 18 years of age or older and must have signed authorization by the parent to bring and pick up the child. This signed authorization must be given to the teacher. A copy will be retained by the teacher and the office. A child will not be released to anyone other than a parent without written parental authorization.

Parents or parent-designated adults are fully responsible for supervising the behavior of their child or children on school and church grounds. Children are not permitted to run or climb on flagpoles and benches on church grounds. No bicycles, skateboards, rollerskates, or rollerblades are allowed on the school premises. Children may not leave the immediate school grounds to wander into the parking lot, field, etc.

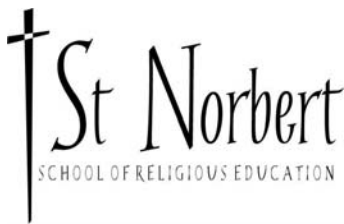
Children are not to be left at class too early (PRIOR TO 5 – 10 MINUTES BEFORE CLASS BEGINNING) or picked up from class too late (AFTER 5 – 10 MINUTES FOLLOWING THE END OF CLASS). Please be prompt. Children may not be left in a classroom unless there is a supervising adult; a teacher or a teacher's aide, present in the room.

During school hours, the MAXIMUM speed in the church parking lot is 10 MILES PER HOUR. During these hours, the maximum speed in the immediate area of the school is 5 MILES PER HOUR. THERE IS NO PARKING NEXT TO THE SCHOOL BUILDING DURING CLASS TIME. PLEASE USE THE DESIGNATED SPACES ONLY.
